

THE ALMINI COMPANY, CHICAGO HISTORY, AND INTERIOR DECORATION by William Tyre

The recent restoration of the two lunette murals in the narthex has brought much deserved attention to the interior decorators, Almini Company. The firm was among the most prominent of the contractors selected by Howard Van Doren Shaw in 1901 to realize his decorating scheme for the sanctuary and adjacent spaces. In this article, we will explore the founding and growth of the firm, its contribution to Shaw's plan, and how an unrelated venture by the predecessor firm preserved an important piece of the church's early history.

ORIGINS

The story of the company begins with Peter M. Almini who was born in Sweden in 1825. When Almini was fourteen years old, he embarked upon a twelve year journey studying under various painters and artists, perfecting his skills in decorative and fresco painting. After two years working as an assistant in the decoration of the palace of the King of Sweden, he left his native land, and by the end of 1852 had settled in Chicago. In 1855 he formed a partnership, Jevne & Almini, with a recently arrived Norwegian immigrant and fresco painter, Otto Jevne. The firm was responsible for the interior decoration of many of Chicago's most prominent buildings until the Chicago Fire of 1871, when the firm was burned out, and each man established his own business.

CHICAGO ILLUSTRATED In 1865, Jevne and Almini launched a venture that resulted in what is generally regarded as the most important and comprehensive visual record of Chicago prior to the Great Fire. Joining with three lithographers, they formed the Chicago Lithographing Company, for the purpose of launching a venture, Chicago Illustrated, which would serve as an illustrated history of Chicago and "a history of the more important and striking evidences of the City's improvement and enterprise." The work was to be issued in 25 parts, priced at \$1.50 each, containing four hand-tinted lithographic views of

the *Chicago Tribune*, was engaged to write the accompanying text.

The first installment of *Chicago Illustrated* was issued in January 1866 and contained lithographs of the Chamber of Commerce building, the Tremont House hotel, the Grand Central Depot, and Second Presbyterian Church. An original framed copy of this lithograph, on permanent loan from the Presbytery of Chicago, is on display in the church, providing visitors with an excellent view of the prior home of the congregation at the northeast corner

public buildings, churches, thoroughfares, the river and harbor, railroad depots, and other points of interest. Louis Kurz, one of the partners of the Chicago Lithographing Co. was the artist, and James W. Sheahan, a journalist for of Wabash and Washington. Known as the "Spotted Church" for its use of a type of limestone with bituminous tar deposits, the building was occupied until one week before the Great Fire. Ultimately, only thirteen installments of *Chicago Illustrated* were issued,

containing a total of 52 illustrations. The business venture was not a success, and many of the copies which did not sell were eventually bound together into single volumes. In the 1920s, over half of the original lithographs were reissued as enlarged aquatints produced by Raoul Varin in Paris. Today, both the original Jevne & Almini lithographs and the later aquatints by Varin remain highly collectible.

POST-FIRE HISTORY

Jevne & Almini's business was destroyed in the 1871 fire, at which time the firm of P. M. Almini & Co. was formed with Charles A. Bourne as the unnamed partner. Col. R. H. Stewart, who had started with the firm in the mid-1860s, was placed in charge of executing important contracts in Chicago and across the country. On January 1, 1887 Bourne retired, and the firm was reorganized as Almini Company, with Peter Almini serving as president and treasurer, and Stewart as secretary and manager. Shortly before Almini's death in October 1890, the firm was reorganized with Stewart as president and Paul Schubert as designer and superintendent of decorations. An article published shortly after Almini's death noted that the firm "did every important piece of decorative work that was executed in Chicago and throughout the Northwest" including three thousand churches and residences in all parts of the country, the Board of Trade, the Town of Pullman, several public buildings in Milwaukee, the Georgia State House, amongst many others. The company was located for many years at 107 Wabash Avenue (now 22 N. Wabash Ave.) and appears to have gone bankrupt shortly before World War I.

SECOND PRESBYTERIAN

The report of the Board of Trustees, dated December 30, 1901, shows that Almini Company was paid a total of \$2,421.55 for decorating the interior of the church. This was a considerable sum, nearly equaling the amount paid for the fabrication and installation of the pews, and more than double the amount paid for the design and installation of the electric lighting fixtures.

The most conspicuous works of the firm are the two large lunette murals on the north and south walls of the narthex. Each features a beautifully stenciled intertwining vine pattern in gold containing pomegranates set against a stunning aqua background. Six excerpts from the Bible – starting at the top of the south mural and ending at the bottom of the north – read as follows:

- Rejoice Evermore (I Thessalonians 5:16)
- Holiness becometh thine house O Lord for ever (Psalm 93:5) You shall keep my Sabbaths and reverence my Sanctuary (Leviticus 19:30) God is Love (I John 4:8) Behold I stand at the door and knock (Revelation 3:20)
- Him that cometh to me I will in no wise cast out (John 6:37)

The firm also executed large bands of stenciled decoration on the front and rear walls of the sanctuary. This repeating design was centered by the image of an hourglass, wrapped within a pair of angel wings, and framed by stylized intertwining grape vines. The front wall was repainted in 1903 with the present Tree of Life mural by Bartlett. (A small portion of the original Almini design survives behind the

organ pipes, see illustration). The back wall, surrounding the Ascension window, was repainted at an unknown date with simple bands of painting, probably after the original was water damaged.

Other decorative painting executed by the firm included the large angel

brackets supporting the chandeliers, additional scriptural passages beneath the clerestory windows (now painted over except for a small section recently revealed at the northwest corner of the sanctuary), stenciled decoration on the ends of the roof trusses, the charming variety of bosses on the ceiling, and stenciled grape vines on the upper walls of the north and south parlors (of which one small section has been revealed).

Although a significant portion of the original Almini decoration has been painted over through the years, when fully restored, its significance to Shaw's master plan for the interior will be fully revealed. The recent restoration of the narthex lunette murals is an important first step in realizing this goal.

NARTHEX LUNETTES CONSERVATION

Originally painted in 1901 by Almini Company, the murals have been compromised by a heavy layer of dirt and grime with decades of airborne pollutants from fossil fuel heating, candles and other airborne accretions making the design and text illegible.



Parma Conservation performed the conservation work. As the murals are painted on lime plaster they needed to be consolidated. This means the internal calcium carbonate and sand was stabilized with a mineral soluble acrylic resin, diluted in an aromatic hydrocarbon solvent. The consolidate was applied by brush to the surface and allowed to penetrate into the plaster substrate.

Once the surface was stable, a micro-emulsion cleaning gel was used to remove dirt and grime. The cleaner was brushed to the surface and then removed with dry cotton swabs, along with surface dirt that dissolved into the gel cleaner. This process was repeated until the surface was clean, revealing the original palette. Overpainting from previous restorations was removed during the process and areas of loss in the painted surface were filled with gesso.

The murals were varnished with a non-yellowing varnish and areas of previous paint loss were color matched and in-painted with Gamblin Conservation Colors. A final coat of Golden MSA Satin varnish was applied to preserve the work.
